### APPOINTMENT OF SECRETARY TO A COMMISSION OF INQUIRY

WHEREAS I, Dr. Mathew Patrick Antonio Herminie, President of the Republic of Seychelles, have deemed it advisable to issue a Commission of Inquiry into the Incident which occurred at Montagne Posee Prison on the 6th to 7th December 2020, resulting in deaths, injuries, and serious allegations concerning the use of force,

AND WHEREAS pursuant the provision of Section 7(1) of the Commission of Inquiry Act 1962, I may appoint a secretary to the Commission,

NOW, THEREFORE, pursuant to section 7(1) of the Commission of Inquiry Act, I hereby APPOINT you, Chelsie Tasha Faith Albest as Secretary to the said Commission of Inquiry issued by written instrument dated 23rd March 2026, which was published in Official Gazette Number 21 on 23rd March 2026.

1. You shall perform the duties of Secretary to the said Commission, which shall comprise of: Recording and accurately maintaining the minutes of the witness testimonies and all records of the Commission's proceedings.

- (a) Keeping and managing the Commission's papers, including all documents and correspondence.
  - (b) Summoning witnesses to appear before the Commission, in accordance with the direction of the Commission.
  - (c) Performing such other duties connected with the inquiry as the Commissioner shall require.
- 3. You shall be accountable to, and shall serve under the direction of, the Commission.
  - 4. This appointment is effective from 25<sup>th</sup> March 2026 and shall remain in force for the duration of the Commission's term, unless otherwise revoked or terminated.

## WRITTEN INSTRUMENT ISSUING AND ESTABLISHING A COMMISSION OF INQUIRY

IN THE MATTER OF Section 3 of the Commission of Inquiry Act (Cap 44) of the Laws of Seychelles

WHEREAS section 2(1)(d) of the Commission of Inquiry Act, 1962 confers upon the President the power to issue a Commission appointing one or more Commissioners to inquire into any matter of public interest or concern;

WHEREAS on the 7 December 2024, a catastrophic explosion occurred at the quarry site operated by the Civil Construction Company Limited at Petite Paris, Mahe, Seychelles, resulting in severe injuries, significant property damage, and profound public concern;

AND WHEREAS the cause, circumstances, and consequences of the said explosion require thorough, independent, and public scrutiny in the interest of justice, public safety, and the rule of law;

AND WHEREAS it is imperative to determine whether all applicable legal frameworks, particularly the Explosives Act, 1966 were complied with by all relevant persons and authorities, and to assess the adequacy and integrity of any investigations conducted following the event;

AND WHEREAS I, Dr Mathew Antonio Patrick Herminie, President of the Republic of Seychelles, am satisfied that the matters and circumstances relating to said explosion are of vital public interest and concern and it is in the public interest to establish an independent Commission of Inquiry to investigate these matters fully and impartially, to ascertain the facts, and to make recommendations to my Office;

NOW, THEREFORE, I, Dr Mathew Antonio Patrick Herminie, by virtue of the powers vested in me by section 2(1) of the Commission of Inquiry Act, 1962 do hereby appoint, constitute, and issue as follows:

### ARTICLE 1: INTERPRETATION

In this Instrument, unless the context otherwise requires, the following terms shall have the meanings ascribed to them below:

“**ACT**” means the Explosives Act, 1966;

“**EXPLOSION**” means the explosion which occurred at the Quarry Site on 7 December 2024;

“**QUARRY SITE**” means the quarry site located at Petit Paris, Mahé, Seychelles, and operated by Civil Construction Company Limited.

## **ARTICLE 2: ISSUE OF A COMMISSION AND APPOINTMENT OF COMMISSIONERS**

- 2.1. There shall be a Commission of Inquiry which shall be known as the Commission of Inquiry into the CCCL Quarry Explosion of 7 December 2024 (hereinafter referred to as "the Commission").
- 2.2. The Commission shall consist of three Commissioners, Justice Nicola Sharpe-Phiri, Ms. Dora Zatte and Mr. Guy Raymond Roucou.
- 2.3 Justice Nicola Sharpe-Phiri is hereby appointed as the Chairman of the Commission.

## **ARTICLE 3: TERMS OF REFERENCE**

The Commission is hereby mandated and required to inquire and investigate into, report upon, and make recommendations concerning all relevant and pertinent matters relating to the Explosion including matters arising prior to, during, and after the Explosion, and in particular, but without limiting the generality of the foregoing, to inquire into:

### **3.1 The Cause and Immediate Circumstances of The Explosion**

- i. The direct and underlying causes of the Explosion.
- ii. The nature, type, and quantity of explosives present at the Quarry Site at the time of the Explosion.
- iii. The circumstances in which the said explosives were stored, handled, and secured, including compliance with manufacturer specifications and industry best practices.

### **3.2 Legal and Regulatory Compliance**

- i. Whether all legal requirements, licenses, and conditions imposed by or under the Act and any other relevant legislation were fully complied with by the Civil Construction Company Limited and any other responsible parties.
- ii. Whether all authorities under the Act, including but not limited to the Chief Inspector of Explosives, duly complied with and discharged their statutory obligations, including inspection, supervision, and enforcement duties, prior to and leading up to the Explosion.

### **3.3 Post-Explosion Investigations**

- i. The nature, scope, methodology, and timeline of all investigations conducted by any person, office, or authority (public or private) into the Explosion and the explosives involved.
- ii. The findings, conclusions, and outcomes of all such investigations.
- iii. The professionalism, independence, impartiality, and thoroughness of the investigation processes.
- iv. The reasons why the report(s) of any such investigation have not been made public, if such is the case.
- v. Whether there was any attempt, by any person, office, or authority, to interfere with, influence, obstruct, or undermine the integrity of any investigation into the Explosion.

#### **3.4 Determination of Liability**

- i. Who may be potentially civilly liable for any loss, damage, or injury arising from the Explosion, including considerations of negligence, breach of statutory duty, and vicarious liability.
- ii. Who may be potentially criminally liable in respect of all matters relating to the Explosion, including but not limited to breaches of the Act, offences under the Penal Code. For the purpose of clarity, such liability shall be considered in relation to acts or omissions occurring before, during, and after the Explosion, including in the conduct or oversight of any investigations.

#### **3.5 General Mandate**

- i. To investigate any other relevant matters which, in the opinion of the Commission, are necessary to fulfil its mandate to ascertain all the relevant and pertinent facts surrounding the Explosion.

### **ARTICLE 4: POWERS AND PROCEDURE**

- 4.1. The Commission shall, for the purpose of its inquiry, have all the powers conferred upon a Commission by the Commission of Inquiry Act, including the power to:
  - (a) Summon any person to attend before it to give evidence or to produce any document or thing in their possession.
  - (b) Examine witnesses and parties concerned on oath, affirmation or declaration, as the case may be.

- (a) Where the Commissioners consider it desirable for the purpose of avoiding expense or delay or for any other special reason, receive evidence by affidavit or administer interrogatories.
  - (b) Do all such other things as are necessary for the proper fulfillment of its mandate, including the power to require the production of any relevant documents or information.
  - (c) Where the Commissioners consider it desirable and necessary, to enter and inspect any relevant premises or site.
  - (d) Require any public officer or any other person to assist it in its work.
- 4.2. The Commission may engage and appoint legal, technical or explosives experts, or such other experts as it deems necessary to assist in its work and to provide expert opinion and analysis on any matters within the Terms of Reference specified in Article 3.
- 4.3. The proceedings of the Commission shall be held in public, save for where the Commission, for reasons of national security, the protection of witnesses, or the administration of justice, determines that certain proceedings should be held in camera.

#### **ARTICLE 5: REPORTING**

The Commission shall submit to my office a final written report of its inquiry, including its findings of fact, its conclusions on the matters specified in the Terms of Reference specified in Article 3, and any recommendations it considers appropriate, within a period of six months from the date of its first sitting, or such further period as I may subsequently authorise upon a request by the Commission.
